- Morton Buildings reached out and offered some information:
  - o Morton offers a lease financing for any building they sell and construct. We would make annual payments for 15 years and then at the end of the lease, the building is owned by the JPA or the City. Along with the lease, we would get complete architectural design for a fee of 1% of the final cost of the building. If we would spend \$3M, the design fee would be \$30,000. We could adjust and modify the design as much as we need for no additional cost. Once the structure is completed and we purchased the building from Morton, the \$30,000 is removed from the total so it would essentially be free design. The only stipulation is that we would need to purchase the building from Morton. If we had them do all the design work and then go with a different construction company, we would still owe the \$30,000.

  - We were not to M and E yet with Bolton and Menk, and they confirmed we have everything we have paid for.
- What does insurance companies say, they may dictate steel vs. wood?
