- Jason Murray Drown and Associates
  - o Consider lease impact
  - He would continue to be a municipal advisor to the JPA

- Get Morton legal documents, have Jason and Fryberger review these documents.
- Jason discuss with Fryberger to ensure that it works with current JPA agreements
  - I have looked at the documents sent. Generally, yes, this is an option the group can decide to move forward with. I would, however, have edits to the documents. To directly answer Bill's questions:
    - No election or reverse referendum applies for lease-purchase agreements.
    - The projects financed by lease-purchase agreements ARE subject to public bidding. For purposes of the bid requirements contained in Minnesota Statutes, Section 471.345, "the amount of the contract" shall include the total of all lease payments for the entire term of the lease under a lease-purchase agreement.
    - Please note that if the dollar amount is over \$1,000,000, it is subject to net debt limitations.
    - Perhaps Jason had already discussed this with you, but this leasepurchase agreement option is something you can do locally here with
      Jason and I. Similar to other direct purchase bond deals, Jason can get
      quotes from different local banks for this lease-purchase structure. As
      your bond counsel, I would draft the required documents. This would
      most likely result in lower costs to do the deal and lower interest
      payments.

- Dustin at Ringdahl Architects
  - 2.6 million-2.7 million range if we took one bay off, combination of wood and metal for the different parts of the building.
  - Feels that a construction manager would not be necessary since Dustin would be able to do it himself.
- o Invite Dustin from Ringdahl Architect to next meeting to present to us.
- Reviewed Pros/Cons with Morton presentation from last meeting
  - o Talked about lease option but increased interest rate to have them finance it.
  - Move the project along and break ground sooner
  - Possibly not a local bank since they are based in Kansas City
