- These are not complete designs that can go to construction and bids, these are just concept designs. Around \$160,000 more to get to construction for precast design.

- **Bolton and Menk**

- Reviewed building and concept design options.
 - Talked about total dollar amount being nothing more \$3 Million
 - But the cost is still up in the air due to June 3rd special meeting for Carlos Township.
 - Construction Quality Options
 - Good, Better, Best
 - In the Construction Admin Number from Bolton and Menk they discussed what is all covered. They want that number to include everything and will not need a check later on, when extra services are needed later on.
 - PEMB would be a \$1.4 million savings from a precast
 - Current Sq Ft around 14,400
 - Specifics codes for a Fire Hall compared to other buildings – yes, example discussed the size of a water line. So it may not be the structure integrity but other things that increase cost.
- Loan/Grant opportunities
 - USDA Loan – adds considerable time to the timeline and has to meet certain specifications; our research shows it would take 24-36 months to abide by their specifications.
 - FEMA BRIC Grant - adds considerable time to the timeline and has to meet certain specifications; our research shows it would take 24-36 months to abide by their specifications.
 - Do we stay with Bolton and Menk –
 - All depends on June 3rd meeting discussion and what dollar amount feels sufficient.
 - Also depends on a more firm number we get from Bolton and Menk to discuss for next meeting.
