A RESOLUTION APPROVING THE FISCAL YEAR 2026 SUMMARY BUDGET STATEMENT FOR PUBLICATION

WHEREAS, the City Council of the City of Carlos is responsible for the review and adoption of the City's annual budget; and

WHEREAS, a Summary Budget Statement for Fiscal Year 2026 has been prepared and presented, outlining the City's proposed revenues, expenditures, and financing sources in accordance with applicable laws and policies; and

WHEREAS, Minnesota Statutes § 471.6965 requires that "*annually, upon adoption of the city budget, the city council shall publish a summary budget statement*" in the City's official newspaper of record or by alternative means as permitted by statute; and

WHEREAS, the City Council has reviewed the Summary Budget Statement and finds it to be consistent with the financial goals, priorities, and long-term fiscal responsibility of the City of Carlos; and

WHEREAS, the City Council desires to comply with all statutory requirements regarding the publication of the Summary Budget Statement;


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Carlos that the Summary Budget Statement for Fiscal Year 2026 is hereby approved; and

BE IT FURTHER RESOLVED that the approved Summary Budget Statement shall serve as the official summary of the City's budget for Fiscal Year 2026 and may be used for reporting, publication, and administrative purposes as required by law; and


BE IT FURTHER RESOLVED that the Mayor and city staff are authorized and directed to take all necessary actions to implement and administer the budget in accordance with this resolution and applicable Minnesota law; and

BE IT FURTHER RESOLVED that the city staff is authorized to publish the Summary Budget Statement in the City's official newspaper of record, or by other statutory alternative methods permitted by Minn. Stat. § 471.6965, in compliance with state law.
